7 **A Resolution appropriating \$35,229.00 for the State Fiscal Year 2011 Community**  
8 **Corrections Act (“SFY2011 CCA”) 407 grant program, for the period 1/1/11 through**  
9 **6/30/11, for the Executive’s Division of Public Safety-Justice Affairs, and declaring an**  
10 **emergency.**

12 WHEREAS, Resolution No. 2010-207 appropriated a total of \$1,239,107.00, in a  
13 SFY2011 CCA 407 grant, awarded for a community corrections programs to be operated by the  
14 County Adult Probation Department and Oriana House, Inc. for the period of 7/1/10 to 6/30/11;  
15 and,

17 WHEREAS, the Ohio Department of Rehabilitation and Corrections provides this  
18 funding on a State fiscal year to support local prison diversion programs, and changes in the  
19 existing Oriana House programs made funds available for a Summit County Reentry Program;

22 WHEREAS, an appropriation for \$35,229.00 is required in order to support the Summit  
23 County Reentry Court staff.

25 WHEREAS, this Council has determined by reviewing all pertinent information that the  
26 appropriation of the aforementioned grant funds is necessary and in the best interest of the  
27 County of Summit;
