7 **A Resolution confirming an award by the Board of Control of the first renewal of four of a**
8 **service agreement with Motorola, Inc., for the 800 MHz Regional Radio System, for the**
9 **period 9/1/10 to 8/31/11, in an amount not to exceed \$102,595.99, for the Executive's**
10 **Department of Law – Division of Public Safety, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held 6/1/11, awarded the first renewal
13 of four of a service agreement with Motorola, Inc., for the 800 MHz Regional Radio System, for
14 the period 9/1/10 to 8/31/11, in an amount not to exceed \$102,595.99, subject to confirmation by
15 County Council; and

17 WHEREAS, County Council has determined by reviewing all pertinent information that
18 the first renewal of the aforementioned service agreement is necessary and in the best interest of
19 the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of the first renewal of four of a service agreement
27 with Motorola, Inc., for the 800 MHz Regional Radio System, for the period 9/1/10 to 8/31/11,
28 in an amount not to exceed \$102,595.99, is hereby confirmed and the County Executive is
29 hereby authorized to execute such renewal.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide a necessary service agreement for the 800 MHz Regional Radio System.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,
