12 contract to provide the aforementioned notices, subject to confirmation by County Council; and,

15 the purchase contract is necessary and in the best interest of the County of Summit;

17 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

22 The award by the Board of Control of a purchase contract with RR Donnelley for the
23 2011 printing and mailing of triennial update property notices, in an amount not to exceed
24 \$105,088.01, is hereby confirmed and the County Executive is hereby authorized to execute such
25 purchase contract.

29 This Resolution is hereby declared an emergency in the interest of the health, safety and
30 welfare of the citizens of the County of Summit, and for the further reason to immediately
31 provide the aforementioned notices.

35 Provided this Resolution receives the affirmative vote of eight members, it shall take
36 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
37 effect and be in force at the earliest time provided by law.

42 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
43 deliberations of this Council and of any of its committees that resulted in such formal action,
