7 **A Resolution confirming an award by the Board of Control of a professional service**

22 The award by the Board of Control of a professional service contract with Jones-Stuckey  
23 Ltd., Inc., for bridge engineering and inspection services, in an amount not to exceed \$68,100.00,  
24 is hereby confirmed and the County Executive is hereby authorized to execute such contract.

28 This Resolution is hereby declared an emergency in the interest of the health, safety and  
29 welfare of the citizens of the County of Summit, and for the further purpose to immediately  
30 provide the aforementioned services.

34 Provided this Resolution receives the affirmative vote of eight members, it shall take  
35 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
36 effect and be in force at the earliest time provided by law.

40 It is found and determined that all formal actions of this Council concerning and relating  
41 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
42 deliberations of this Council and of any of its committees that resulted in such formal action,

44 121.22 of the Ohio Revised Code.
