24 The award by the Board of Control of various professional service contracts per attached
25 Exhibit A for the first and final renewal of title examination services on foreclosure of real
26 property for non-payment of real estate taxes, for the period 5/1/11 to 4/30/13, in a total amount
27 not to exceed \$500,000.00, is hereby confirmed and the County Executive is hereby authorized
28 to execute such contracts.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further purpose to immediately
34 provide the aforementioned services.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,
