7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Brinks, for the first renewal of two, for armored car services for various county**
9 **departments, for a one-year period, in an amount not to exceed \$2,724.01 per month**
10 **(including an estimated 10% fuel surcharge), for a total amount not to exceed \$32,688.12**
11 **per year, for the Executive's Department of Finance and Budget - Purchasing, and**
12 **declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held July 27, 2011, awarded a purchase
15 contract to provide the aforementioned services, subject to confirmation by County Council; and,

17 WHEREAS, County Council has determined by reviewing all pertinent information that
18 the purchase contract is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

25 The award by the Board of Control of a purchase contract with Brinks, for the first
26 renewal of two, for armored car services for various county departments, for a one-year period,
27 in an amount not to exceed \$2,724.01 per month (including an estimated 10% fuel surcharge),
28 for a total amount not to exceed \$32,688.12 per year, is hereby confirmed and the County
29 Executive is hereby authorized to execute such purchase contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide the aforementioned services.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,

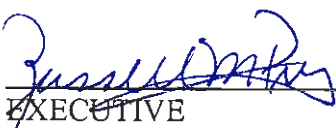
