13 purchase contract to provide the aforementioned vehicle, subject to confirmation by County
14 Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that
17 the purchase contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of a purchase contract with Specialty Vehicle
25 Solutions, LLC, for a digital surveillance vehicle, as Sole Source, for the Drug Unit, in an
26 amount not to exceed \$113,558.00, is hereby confirmed and the County Executive is hereby
27 authorized to execute such purchase contract.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide the aforementioned vehicle.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.




