7 **A Resolution authorizing the County Executive to enter into a three-year policing**  
8 **agreement with Twinsburg Township, Council District 1, to provide seven Sheriff's**  
9 **Deputies, for the period 1/1/12 through 12/31/14, in the amount of \$743,149.33 for the first**  
10 **year, \$751,696.67 for the second year, and \$756,212.00 for the third year, in a total amount**  
11 **not to exceed \$2,251,058.00 during the three-year term of the agreement, for the Sheriff,**  
12 **and declaring an emergency.**

13  
14 WHEREAS, the County Executive entered into a policing contract with Twinsburg  
15 Township which terminates on 12/31/11; and

16  
17 WHEREAS, Twinsburg Township hereby requests that the Executive enter into a new  
18 three-year agreement to provide seven Sheriff's Deputies for the period 1/1/12 through 12/31/14;  
19 and

21 WHEREAS, Twinsburg Township has agreed to pay the County \$743,149.33 for the first  
22 year, \$751,696.67 for the second year, and \$ 756,212.00 for the third year, for a total amount of  
23 \$2,251,058.00 during the three-year term of agreement; and

25 WHEREAS, this Council has determined by reviewing all pertinent information that  
26 authorizing the Executive to execute the aforementioned policing agreement with Twinsburg  
27 Township is necessary and in the best interest of the County of Summit;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
30 of Ohio, that;

32 SECTION 1

34 The County Executive is hereby authorized to enter into a three-year policing agreement  
35 with Twinsburg Township, Council District 1, to provide seven Sheriff's Deputies for the period  
36 1/1/12 through 12/31/14, in the amount of \$743,149.33 for the first year, \$751,696.67 for the  
37 second year, and \$756,212.00 for the third year, for a total amount of \$2,251,058.00 during the  
38 three-year term of the agreement.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and  
43 welfare of the citizens of the County of Summit and for the further purpose of immediately  
44 providing necessary policing for Twinsburg Township.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take  
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
50 effect and be in force at the earliest time provided by law.
