7 **A Resolution authorizing the County Executive to execute a use agreement with Hattie**
8 **Larlham, or a Hattie Larlham-affiliated entity, to provide dog grooming services to the**
9 **public in the grooming room at the County of Summit Animal Control Facility, 250**
10 **Opportunity Parkway, Akron, Ohio 44304-1218, in Council District 5, for the Executive's**
11 **Department of Administrative Services-Division of Animal Control, and declaring an**
12 **emergency.**

14 WHEREAS, Hattie Larlham provides day care and grooming for dogs to the public
15 through Hattie Larlham Doggie Day Care & Boarding; and

16
17 WHEREAS, Hattie Larlham wishes to provide dog grooming services to the public in the
18 grooming room at the County of Summit Animal Control Facility, 250 Opportunity Parkway,
19 Akron, Ohio 44304-1218, in Council District 5; and

21 WHEREAS, Hattie Larlham or a Hattie Larlham-affiliated entity, will provide such
22 services, during days and times mutually agreed to by the County and Hattie Larlham, using one
23 employee and two client volunteers; and

25 WHEREAS, by providing use of the grooming run, the County will be assisting Hattie
26 Larlham in its mission of enhancing the quality of life for people with disabilities and their
27 families; and

29 WHEREAS, it is necessary to execute a use agreement between the County and Hattie
30 Larlham to define the rights and duties of the parties concerning the use of the grooming room;

33 WHEREAS, County Council has determined by reviewing all pertinent information that
34 it is necessary and in the best interest of the County of Summit to authorize the Executive to
35 execute the aforementioned use agreement with Hattie Larlham, or a Hattie Larlham-affiliated
36 entity, to provide dog grooming services to the public in the grooming room at the Animal
37 Control Facility;

39 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
40 of Ohio, that:

44 The County Executive is hereby authorized to execute a use agreement with Hattie
45 Larlham, or a Hattie Larlham-affiliated entity, to provide dog grooming services to the public in
46 the grooming room at the County of Summit Animal Control Facility, 250 Opportunity Parkway,
47 Akron, Ohio 44304-1218, in Council District 5.
