13 purchase contract to provide the aforementioned project, subject to confirmation by County
14 Council; and,

17 the purchase contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

24 The award by the Board of Control of a purchase contract with GCS Industrial Services,
25 Inc., for the Indoor Firing Range Remediation Project for the Training Facility, in an amount not
26 to exceed \$36,744.00, is hereby confirmed and the County Executive is hereby authorized to
27 execute such purchase contract.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide the aforementioned project.

38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.
