10 **Administrative Services-Physical Plants, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the County of Summit
16 Children Services Board visitation center renovation project, in Council District 4, for an
17 estimated total cost not to exceed \$302,000.00; and

19 WHEREAS, a copy of the bid package is on file in the office of the Clerk of Council; and

21 WHEREAS, the cost of the aforementioned contract shall be paid for by Children
22 Services; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that is necessary and in the best interest of the County of Summit to authorize the Executive to
26 advertise for bids for the aforementioned project;

33 The County Executive is authorized to advertise for bids for the County of Summit
34 Children Services Board visitation center renovation project, in Council District 4, for an
35 estimated total cost not to exceed \$302,000.00.

40 of the citizens of the County of Summit, and for the further reason that it authorizes the
41 Executive to immediately advertise for bids for the Children Services Board visitation center
