7 **A Resolution authorizing the County Executive to execute an agreement with the Pastor**  
8 **Family Trust, Thomas B. and Linda D. Pastor as co-trustees, in the amount of \$7,300.00,**  
9 **for an easement on their property, as part of the Whitefriars Sanitary Sewer Improvement**  
10 **Project Q-827 ("Project") in the Township of Coventry, in Council District 8, for the**  
11 **Executive's Department of Environmental Services, and declaring an emergency.**

13 WHEREAS, County Council previously passed Resolution No. 2011-263, which  
14 approved the detailed plans, specifications and estimate of cost of the Project, which will extend  
15 sanitary sewer down South Main Street and Whitefriars Drive in the Township of Coventry, in  
16 Council District 8; and

17  
18 WHEREAS, the County of Summit desires to authorize the County Executive to execute  
19 an agreement with the Pastor Family Trust, Thomas B. and Linda D. Pastor as co-trustees, in the  
20 amount of \$7,300.00 for an easement on their property located at 3546 South Main Street in the  
21 Township of Coventry, Parcel Nos. 1903948 and 1909359, in Council District 8, as part of the  
22 Project; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that it is necessary and in the best interest of the County of Summit to authorize the County  
26 Executive to execute an agreement with the Pastor Family Trust, Thomas B. and Linda D. Pastor  
27 as co-trustees, in the amount of \$7,300.00, to acquire the aforementioned easement as part of the  
28 Project;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that;

33 SECTION 1

35 The County Executive is hereby authorized to execute an agreement with the Pastor  
36 Family Trust, Thomas B. and Linda D. Pastor as co-trustees, in the amount of \$7,300.00, for an  
37 easement on their property located at 3546 South Main Street in the Township of Coventry,  
38 Parcel Nos. 1903948 and 1909359, as part of the Whitefriars Sanitary Sewer Improvement  
39 Project Q-827 ("Project"), and to accept said easement for the County of Summit, in Council  
40 District 8.

42 SECTION 2

44 This Resolution is hereby declared an emergency in the interest of the health, safety and  
45 welfare of the citizens of the County of Summit and for the purpose of allowing construction of  
46 the Project to proceed immediately.

48 SECTION 3

50 Provided this Resolution receives the affirmative vote of eight members, it shall take  
51 effect immediately upon its adoption and approval of the Executive; otherwise, it shall take  
52 effect and be in force at the earliest time provided by law.

10 of the Ohio Revised Code.


