7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Greenleaf Family Center for four to six weeks of family therapy services**

10 **not to exceed \$45,385.00, for the County of Summit Juvenile Court, and declaring an**

13 WHEREAS, the Board of Control, at its meeting held November 30, 2011, awarded a
14 professional service contract with Greenleaf Family Center for four to six weeks of family
15 therapy services through the Teens on Task Program, for the period 1/1/12 through 12/31/12, in
16 an amount not to exceed \$45,385.00, subject to confirmation by County Council; and,

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the aforementioned contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a professional service contract with Greenleaf
27 Family Center for four to six weeks of family therapy services through the Teens on Task
28 Program, for the period 1/1/12 through 12/31/12, in an amount not to exceed \$45,385.00, is
29 hereby confirmed and the County Executive is hereby authorized to execute such contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further purpose of immediately
35 authorizing family therapy services for 2012.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
