7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award by the Ohio Department of Youth Services of a Title II formula grant for**  
9 **a Juvenile Court Diversion Program, for the period 1/1/12 through 12/31/12, in the amount**  
10 **of \$103,232.00, with no local cash match requirement, and appropriating these federal**  
11 **funds for expenditures in calendar year 2012, for the County of Summit Juvenile Court,**  
12 **and declaring an emergency.**

13  
14 WHEREAS, the Ohio Department of Youth Services has awarded a Title II formula grant  
15 to the County of Summit Juvenile Court, for the period 1/1/12 through 12/31/12, in the amount  
16 of \$103,232.00, with no local cash match requirement, for a diversion program; and

17 WHEREAS, this is the fourth year of funding for this diversion program, which will  
18 serve approximately 200 youths and is focused on African American and other minorities in the  
19 10-17 age range; and

21 WHEREAS, this grant will provide funding for Juvenile Court case management services  
22 and for contracted services with Greenleaf for further assessments, planning, counseling, and  
23 treatment for this population; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
26 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
27 execute any documents necessary to accept the award of the aforementioned grant from the Ohio  
28 Department of Youth Services, and to appropriate these grant funds;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that:

35 The County Executive is hereby authorized to execute any documents necessary to accept  
36 the Title II formula grant award of federal funds from the Ohio Department of Youth Services,  
37 for the period 1/1/12 through 12/31/12, in the amount of \$103,232.00, with no local cash match



21 effect and be in force at the earliest time provided by law.


