7 **A Resolution authorizing the County Executive to execute a subgrant agreement, as a**  
8 **representative of Workforce Investment Act Local Area 2, with the Ohio Department of**  
9 **Job and Family Services and the Medina County Department of Job and Family Services,**  
10 **for a Workforce Investment Act Local Area 2 grant for Workforce Investment Act**  
11 **Disability Employment Initiative funds, during the period of 1/1/12 through 9/30/14, for the**  
12 **Executive's Department of Job and Family Services, and declaring an emergency.**

13  
14 WHEREAS, Section 5101.21 of the Ohio Revised Code provides, commencing 7/1/08,  
15 that the Ohio Department of Job and Family Services ("Ohio DJFS") may only make grants to  
16 counties through subgrant agreements as described in that Section; and

17  
18 WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, Ohio DJFS  
19 developed a standard subgrant agreement to be executed by the commissioners of each county  
20 prior to receiving Ohio DJFS grant funds; and

22 WHEREAS, the County of Summit Department of Job and Family Services ("Summit  
23 DJFS") and the Medina County Department of Job and Family Services ("Medina DJFS") have  
24 previously executed the subgrant agreement for the Workforce Investment Act ("WIA") Local  
25 Area 2's routine WIA funds for the period 7/1/11 through 6/30/13; and

26  
27 WHEREAS, Ohio DJFS has notified Summit DJFS and Medina DJFS that WIA Local  
28 Area 2 will be the recipient of \$6,966.00 in WIA Disability Employment Initiative ("WIA DEI")  
29 funds, and has requested that Summit DJFS and Medina DJFS execute a subgrant agreement  
30 governing receipt of those funds during the period 1/1/12 through 9/30/14; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
33 that it is necessary and in the best interest of the County of Summit to authorize the County  
34 Executive to execute said subgrant agreement for WIA DEI funds for the period 1/1/12 through  
35 9/30/14;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
38 of Ohio, that:

40 SECTION 1

42 The County Executive is hereby authorized to execute a subgrant agreement, as a  
43 representative of Workforce Investment Act ("WIA") Local Area 2, with Ohio DJFS and Medina  
44 DJFS governing the receipt of WIA Disability Employment Initiative funds by WIA Local Area  
45 2 during the period of January 1, 2012 through September 30, 2014. A copy of said subgrant  
46 agreement is attached hereto as Exhibit A and incorporated herein by reference.

6 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
7 welfare of the citizens of the County of Summit, and for the further reason that it is necessary to  
8 immediately execute said subgrant agreement so that the State may immediately award said  
9 funds and said funds can begin being expended within Summit and Medina Counties.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take  
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and shall be in force at the earliest time provided by law.

19 It is found and determined that all formal action of this Council concerning and relating  
20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
21 deliberations of this Council and of any of its committees that resulted in such formal action,

23 121.22 of the Ohio Revised Code.
