7 **A Resolution authorizing the County Executive to advertise for bids for construction of the**
8 **Q-162 Pump Station No. 56 Abandonment Project, in the City of Macedonia, in Council**
9 **District 1, for an estimated total cost not to exceed \$120,000.00, for the Executive's**
10 **Department of Environmental Services, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

14
15 WHEREAS, the County Executive wishes to advertise for bids for the Q-162 Pump
16 Station No. 56 Abandonment Project, which includes the abandonment of the County's Pump
17 Station No. 56 and construction of approximately 815 feet of new 12 inch gravity sewer, in the
18 City of Macedonia, Council District 1, for an estimated total cost not to exceed \$120,000.00; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that authorizing the County Executive to advertise for bids for the Q-162 Pump Station No. 56
22 Abandonment Project is necessary and in the best interest of the County of Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that;

29 The County Executive is authorized to advertise for bids for construction of the Q-162
30 Pump Station No. 56 Abandonment Project in the City of Macedonia, in Council District 1
31 respectively, for an estimated total cost not to exceed \$120,000.00.

35 This Resolution is declared an emergency in the interest of the health, safety, and welfare
36 of the citizens of the County of Summit, and for the further reason that it authorizes the
37 Executive to immediately advertise for bids for this needed cost-saving sanitary sewer
38 improvement in the City of Macedonia.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.
