7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Sheriff to hire one**
9 **external person into the full-time classified position of Civil Clerk I, at an annual salary of**
10 **\$23,296.00, the minimum salary for the position, for the Sheriff, and declaring an**
11 **emergency.**

13 WHEREAS, County Council previously adopted Ordinance No. 2009-110, which
14 enacted Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled,
15 "Temporary Hiring Freeze," to control and reduce the County's budget deficit and Ordinance
16 No. 2011-204, which reinstated the hiring freeze through December 31, 2012; and

18 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that
19 the filling of an existing position by hiring an employee is necessary for the effective and
20 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
21 said employees; and

23 WHEREAS, the County Sheriff says it is necessary for the continued and effective
24 operation of his Civil Division, to be permitted to hire one external person into the full-time
25 classified position of Civil Clerk I, at an annual salary of \$23,296.00, the minimum salary for
26 Civil Clerk I ; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County of Summit to authorize the County
30 Sheriff to hire one external person into the full-time classified position of Civil Clerk I, at the
31 aforementioned annual salary;

33 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
34 State of Ohio, that:

38 County Council hereby determines that the County Executive has demonstrated that it is
39 necessary for the effective and continued operation of the office to authorize the Sheriff,
40 pursuant to Section 169.04(j) of the Codified Ordinance, to hire one external person into the full-
41 time classified position of Civil Clerk I, at an annual salary of \$23,296.00, the minimum salary
42 for the position.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the citizens of the County of Summit and for the further reason to immediately
48 authorize the County Sheriff to hire one external person into the full-time classified position of
49 Civil Clerk I, for the continued and effective operation of the Civil Division for the Summit
50 County Sheriff's Office.

16 121.22 of the Ohio Revised Code.


