13 WHEREAS, the Board of Control, at its meeting held April 11, 2012, awarded a renewal
14 of a professional service contract with Tyler Technologies for the CRIS+Plus system software
15 support agreement, for the period 5/1/12 through 4/30/13, as Sole Source, approved by the IT
16 Board 4/10/12, subject to confirmation by County Council; and,

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract renewal is necessary and in the best interest of the County of Summit;

29 \$36,670.00, is hereby confirmed and the County Executive is hereby authorized to execute such
30 contract renewal.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide CRIS+Plus software support beginning 5/1/12.

41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.
