7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Kone, Inc., as lowest responsive and responsible bidder, for the four-year full maintenance**
9 **service contract for elevators in the Ohio Building, in Council District 4, in an amount not**
10 **to exceed \$32,840.00, for the Executive's Department of Administrative Services-Physical**
11 **Plants, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held March 28, 2012, awarded a
14 purchase contract with Kone, Inc., as lowest responsive and responsible bidder, for the four-year
15 full maintenance service contract for elevators in the Ohio Building, in Council District 4,
16 subject to confirmation by County Council; and,

18 WHEREAS, County Council has determined by reviewing all pertinent information that
19 the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a purchase contract with Kone, Inc., as lowest
27 responsive and responsible bidder, for the four-year full maintenance service contract for
28 elevators in the Ohio Building, in Council District 4, in an amount not to exceed \$32,840.00, is
29 hereby confirmed and the County Executive is hereby authorized to execute such contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide the aforementioned maintenance service contract.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
