7 **A Resolution authorizing the County Executive to execute an Intergovernmental**
8 **Agreement with the City of Barberton concerning the provision of copying and printing**
9 **services by the County to Barberton through the Executive's Department of Finance and**
10 **Budget, Division of Office Services, for the Executive, and declaring an emergency.**

12 WHEREAS, the County of Summit maintains and operates a Division of Office Services
13 through the Executive's Department of Finance and Budget, which provides copying and
14 printing services to the County; and

15
16 WHEREAS, the City Barberton wishes to utilize said services, provided that it shall be
17 invoiced and shall pay for any such services rendered, consistent with the County's Division of
18 Office Services' pricing sheet; and

20 WHEREAS, it is necessary for the parties to execute an Intergovernmental Agreement to
21 set forth the rights and duties of the parties concerning the provision of copying and printing
22 services by the County to Barberton;

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to authorize the County
26 Executive to execute an Intergovernmental Agreement between the County and Barberton for the
27 aforementioned purposes;

29 NOW, THEREFORE, IT IS HEREBY RESOLVED by the Council of the County of
30 Summit, State of Ohio, that:

32 SECTION 1

34 The County Executive is hereby authorized to execute an Intergovernmental Agreement
35 with the City of Barberton concerning the provision of copying and printing services by the
36 County to Barberton through the Executive's Department of Finance and Budget, Division
37 Office Services. A copy of the Intergovernmental Agreement is attached hereto as Exhibit A and
38 incorporated herein as if fully restated.

40 SECTION 2

42 This Resolution is hereby declared an emergency in the interest of the health, safety and
43 welfare of the citizens of the County of Summit, and for the further reason that it is necessary in
44 order to immediately authorize the Division of Office Services to begin providing copying and
45 printing services to Barberton.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.


