7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the additional Community Corrections Act 407 grant award from the State of Ohio**
9 **Department of Rehabilitation and Correction, and appropriating the grant funds, in the**
10 **amount of \$16,000.00, with no local cash match requirement, through State Fiscal Year**
11 **2012, for both the Day Reporting and the Reentry Community Corrections Programs**
12 **operated by Oriana House, Inc., for the period 1/1/12 through 6/30/12, and appropriating**
13 **grant funds, for Executive's Department of Law, Insurance and Risk Management -**
14 **Division of Public Safety/Justice Affairs, and declaring an emergency.**

16 WHEREAS, State of Ohio Department of Rehabilitation and Correction ("ODRC"),
17 through the Community Corrections Act ("CCA"), awarded the County of Summit a 407 Grant
18 for State Fiscal Year 2012, in the amount of \$1,006,199.00, with no local cash match
19 requirement, for a community corrections program to be operated by the County Adult Probation
20 Department and Oriana House, Inc., for the period of 7/1/11 through 6/30/12; and

22 WHEREAS, ODRC, through the CCA, subsequently awarded the County of Summit
23 additional 407 Grant funding for State Fiscal Year 2012, in the amount of \$232,908.00, with no
24 local cash match requirement, for a Reentry Court as part of the community corrections program,
25 for the period of 7/1/11 through 6/30/12; and

27 WHEREAS, this Council previously adopted Resolution No. 2011-174 and Resolution
28 No. 2011-394 which authorized the County Executive to execute documents necessary to accept
29 the aforementioned grant awards and appropriate these grant funds; and

31 WHEREAS, additional ODRC funding has been made available for the State Fiscal Year
32 2012 CCA 407 Grant in the amount of \$16,000.00, with no local cash match requirement, to
33 support bus passes and client rewards for both the Day Reporting and the Reentry Court
34 Programs operated by Oriana House, Inc., for the period 1/1/12 through 6/30/12; and

36 WHEREAS, it is necessary for the County Executive to execute documents, to accept the
37 aforementioned additional 407 grant funds, and to appropriate the grant funds; and

39 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
40 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
41 execute any document necessary to accept the CCA 407 additional grant funds in the amount of
42 \$16,000.00, with no local cash match requirement, for the period 1/1/12 through 6/30/12;
