7 **An Ordinance amending Chapter 164A of the Codified Ordinances of the County of**
8 **Summit, entitled "Port Authority," to change the name of the Summit County Port**
9 **Authority to the Development Finance Authority of Summit County, effective April 1,**
10 **2012, to more accurately reflect its economic development activities, for the Executive, and**
11 **declaring an emergency.**

12
13 WHEREAS, Chapter 164A of the Codified Ordinances of the County of Summit, entitled
14 "Port Authority" created the Summit County Port Authority ("Port Authority") and sets forth the
15 composition, roles, responsibilities and duties of the Port Authority; and

16
17 WHEREAS, since the adoption of Chapter 164A and the creation of the Port Authority
18 thereunder, the Port Authority has accelerated its focus on economic development and economic
19 development finance activities while eliminating its initial function of acquiring abandoned
20 railroad lines located in the County of Summit; and

21
22 WHEREAS, in order to reflect its economic development finance activities, the County
23 Executive recommends that the official name of the Summit County Port Authority be changed
24 to the Development Finance Authority of Summit County effective April 1, 2012; and

26 WHEREAS, in order to implement the name change it is necessary to amend Chapter
27 164A; and

29 WHEREAS this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to amend Chapter 164A to
31 change the name of the Summit County Port Authority to the Development Finance Authority of
32 Summit County, effective April 1, 2012, to more accurately reflect its focus on economic
33 development activities;

35 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State
36 of Ohio, that

38 SECTION 1

40 Chapter 164A of the Codified Ordinances of the County of Summit, entitled "Port
41 Authority," is hereby amended as set forth in Exhibit A, attached hereto and incorporated herein
42 as if fully restated.

44 SECTION 2

46 All other references to the Summit County Port Authority in the Codified Ordinances are
47 hereby amended, effective April 1, 2012, to refer to the Development Finance Authority of
48 Summit County and the Clerk of Council is authorized and directed to make said changes. All
49 prior references to the Summit County Port Authority shall, effective April 1, 2012, mean the
50 Development Finance Authority of Summit County.

4 SECTION 3

6 This Ordinance is hereby declared an emergency in the interest of the health, safety and
7 welfare of the citizens of the County of Summit, and for the further reason of immediately
8 amending Chapter 164A to change the name of the Summit County Port Authority to the
9 Development Authority of Summit County to allow the Development Authority to immediately
10 begin using the new name on April 1, 2012.

12 SECTION 4

13
14 Provided this Ordinance receives the affirmative vote of eight members, it shall take
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
16 effect and be in force at the earliest time provided by law.

18 SECTION 5

20 It is found and determined that all formal actions of this Council concerning and relating
21 to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all
22 deliberations of this Council and of any of its committees that resulted in such formal action,
23 were in meetings open to the public, in compliance with all legal requirements, including Section
24 121.22 of the Ohio Revised Code.
