7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Prosecutor to hire**
9 **one external person as a part-time, unclassified Direct Indictment Officer I to fill a vacant**
10 **position, at the rate of \$14.90 per hour, the minimum pay rate for the position, to be fully**
11 **funded through the Direct Indictment Agreement with the City of Akron, for the**
12 **Prosecutor, and declaring an emergency.**

14 WHEREAS, this Council previously adopted Ordinance No. 2009-110, which enacted
15 Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled, "Temporary
16 Hiring Freeze," to control and reduce the County's budget deficit and Ordinance No. 2011-204,
17 which reinstated the hiring freeze through December 31, 2012; and

18
19 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that
20 the filling of an existing position by hiring an employee is necessary for the effective and
21 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
22 said employees; and

24 WHEREAS, due to separation through resignation of a part-time, unclassified Direct
25 Indictment Officer I, the Prosecutor says it is necessary for the continued and effective operation
26 of her office to be permitted to hire and fill this vacancy; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County of Summit to authorize the County
30 Prosecutor to hire one external person as a part-time unclassified Direct Indictment Officer I at
31 the rate of \$14.90 per hour, the minimum pay rate for the position;

33 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
34 State of Ohio, that:

38 County Council hereby determines that the County Prosecutor has demonstrated that it is
39 necessary for the effective and continued operation of her office to authorize the County
40 Prosecutor, pursuant to Section 169.04(j) of the Codified Ordinance, to hire one external person
41 as a part-time, unclassified Direct Indictment Officer I at the rate of \$14.90 per hour, the
42 minimum pay rate for the position.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the citizens of the County of Summit and for the further reason to immediately
48 authorize the County Prosecutor to hire one external person as a part-time Direct Indictment
49 Officer I to fill a vacancy in order to continue effectively prosecuting cases and collect revenue
50 for Summit County.


