7 **A Resolution authorizing the County Executive to execute a professional service contract**
8 **with the Legal Defenders Office of Summit County, Inc., subject to the approval of the**
9 **Board of Control, for legal defender services for indigents, for the Summit County Public**
10 **Defender Commission, for the period 1/1/12 to 12/31/12, in an amount not to exceed**
11 **\$472,900.00, for the Executive's Department of Law, Insurance and Risk Management and**
12 **declaring an emergency.**

14 WHEREAS, the County has formed the Summit County Public Defender Commission
15 pursuant to Chapter 120 the Ohio Revised Code ("ORC"); and

16
17 WHEREAS, the Commission is responsible for providing legal defense services to
18 certain indigent persons charged with the commission of crimes under the ORC, the Codified
19 Ordinances of the County of Summit and various municipal ordinances within the boundaries of
20 the County; and

22 WHEREAS, the Commission is authorized by Section 120.14 of the Ohio Revised Code
23 to contract with a non-profit organization to provide legal services to indigent persons; and

25 WHEREAS, the Commission wishes to contract with the Legal Defenders Office of
26 Summit County, Ohio, Inc., a not-for-profit corporation, to provide legal representation to
27 indigent persons on behalf of the Commission from 1/1/12 to 12/31/12, for an amount not to
28 exceed \$472,900.00; and

30 WHEREAS, the County Executive is required to execute the aforementioned contract,
31 the cost of which will be paid out of funds appropriated by Council in Account No. 10003-2711-
32 45501 pursuant to Resolution No. 2011-483; and

34 WHEREAS, this County Council finds and determines, after reviewing all pertinent
35 information, that the Executive should be authorized to execute the aforementioned contract with
36 the Legal Defenders Office of Summit County, Ohio, Inc., subject to the approval of the Board
37 of Control;

39 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
40 of Ohio, that:

44 The County Executive is hereby authorized to execute a professional service contract
45 with the Legal Defenders Office of Summit County, Inc., subject to the approval of the Board of
46 Control, for legal defender services for indigents, for the Summit County Public Defender
47 Commission, for the period 1/1/12 to 12/31/12, for an amount not to exceed \$472,900.00.
