7 **A Resolution confirming an award by the Board of Control of a super specific blanket**
8 **purchase order with Shaw Automotive for reasonable reoccurring historical automobile**
9 **repair expenses for fleet vehicles, as Best Practical Source, in an amount not to exceed**
10 **\$150,000.00, for the Sheriff, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held January 18, 2012, awarded a
13 purchase order to provide a super specific blanket purchase order with Shaw Automotive for
14 reasonable reoccurring historical automobile repair expenses for fleet vehicles, as Best Practical
15 Source, in an amount not to exceed \$150,000.00, subject to confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the purchase order is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

25 The award by the Board of Control of a super specific blanket purchase order with Shaw
26 Automotive for reasonable reoccurring historical automobile repair expenses for fleet vehicles,
27 as Best Practical Source, in an amount not to exceed \$150,000.00, is hereby confirmed and the
28 County Executive is hereby authorized to execute such purchase order.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide the aforementioned repairs.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,

48 121.22 of the Ohio Revised Code.
