A Resolution confirming an award by the Board of Control for a professional service contract with Armada Group, Inc., for a one-year renewal (second of five) to provide data and information sharing services through its proprietary iLincs program to law enforcement agencies in Ohio Homeland Security Region 5, for the period 1/1/12 through 12/31/12, in an amount not to exceed \$275,000.00, for the Executive's Department of Law, Insurance and Risk Management - Division of Public Safety/Emergency Management, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2009-016, which confirmed the award by the Board of Control of a professional service contract with Armada Group, Inc., to provide data and information sharing services through its proprietary iLincs program for law enforcement agencies in Ohio Homeland Security Region 5 and the Summit County Emergency Management Agency; and

WHEREAS, Resolution No. 2010-289 authorized the first amendment and renewal through 12/31/11 of the aforementioned professional service agreement; and

WHEREAS, on December 27, 2011, the Region 5 Law Enforcement – State Homeland Security Grant Program ("LE-SHSP") Grant Advisory Committee voted to recommend the County approve a one-year renewal (second of five), for the period 1/1/12 through 12/31/12, in an amount not to exceed \$275,000.00, to be funded through the State Fiscal Year 2010 LE-SHSP; and

WHEREAS, the IT Board approved the aforementioned agreement on 1/17/12; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit that the Executive be authorized to execute the second renewal of the aforementioned contract from 1/1/12 through 12/31/12, in an amount not to exceed \$275,000.00;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1
