7 **A Resolution authorizing the County Executive to advertise for bids for a five-year full**  
8 **maintenance service agreement for heating, air conditioning and ventilation at the Summit**  
9 **County Jail, 205 East Crosier Street, Akron, Ohio 44311, in Council District 4, for an**  
10 **estimated total cost not to exceed \$650,000.00, for the Executive's Department of**  
11 **Administrative Services-Physical Plants, and declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
14 requires this Council's authorization for the County Executive to advertise for bids; and

15  
16 WHEREAS, the County Executive wishes to advertise for bids for a five-year full  
17 maintenance service agreement for heating, air conditioning and ventilation at the Summit  
18 County Jail, 205 East Crosier Street, Akron, Ohio 44311, in Council District 4, for an estimated  
19 total cost not to exceed \$650,000.00; and

21 WHEREAS, a copy of the specifications are on file in the office of the Clerk of Council;

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
26 advertise for bids for the aforementioned project;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that;

33 The County Executive is authorized to advertise for bids for a five-year full maintenance  
34 service agreement for heating, air conditioning and ventilation at the Summit County Jail, 205  
35 East Crosier Street, Akron, Ohio 44311, in Council District 4, for an estimated total cost not to  
36 exceed \$650,000.00.

40 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
41 of the citizens of the County of Summit, and for the further reason that it authorizes the  
42 Executive to immediately advertise for bids for the aforementioned agreement in order to have a  
43 new contract in place when the current contract expires on May 31, 2012.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take  
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
49 effect and be in force at the earliest time provided by law.
