7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award of a Probation Improvement and Incentive Technology and Training**
9 **Grant, in the amount of \$199,100.00, with no local cash match, from the Ohio Department**
10 **of Rehabilitation and Correction, which will enhance reporting and provide staff training,**
11 **in calendar year 2012, for the Court of Common Pleas-General Division, and declaring an**
12 **emergency.**

14 WHEREAS, the Ohio Department of Rehabilitation and Correction has awarded the
15 Summit County Court of Common Pleas-General Division, Adult Probation Department, a
16 Probation Improvement and Incentive Technology and Training Grant, in the amount of
17 \$199,100.00, for a program designed to enhance reporting and provide staff training in 2012; and

19 WHEREAS, the aforementioned grant will assist the Summit County Adult Probation
20 Department with their adoption of Evidence Based Practices, for the proper services for
21 probationers, based on the individual's level of risk, as determined by the Ohio Risk Assessment
22 System (ORAS); and

24 WHEREAS, approximately \$100,000.00 will be used to implement a Kiosk reporting
25 project for low to medium risk offenders; and the balance will be designated for staff training
26 and travel, as well as contingencies; and

28 WHEREAS, this Council has determined by reviewing all pertinent information that it is
29 necessary and in the best interest of the County of Summit to authorize the Executive to execute
30 any documents necessary to accept the award of the aforementioned grant from the Ohio
31 Department of Rehabilitation and Correction;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

38 The County Executive is hereby authorized to execute any documents necessary to accept
39 the award from the Ohio Department of Rehabilitation and Correction for the Probation
40 Improvement and Incentive Technology and Training Grant for the Summit County Court of
41 Common Pleas-General Division, Adult Probation Department, in the amount of \$199,100.00,
42 with no local cash match requirement.
