7 **A Resolution appropriating carryover grant funds received from the State of Ohio**
8 **Department of Rehabilitation and Correction for the State Fiscal Year 2012 Community**
9 **Corrections Act 407 and 408 grant programs, in the amount of \$205,379.08, with no local**
10 **cash match requirement, through 6/30/12, for the Executive's Department of Law,**
11 **Insurance and Risk Management, Division of Public Safety/Justice Affairs, and declaring**
12 **an emergency.**

14 WHEREAS, the State of Ohio Department of Rehabilitation and Correction, through the
15 Community Corrections Act ("CCA") grant program, makes funds available to assist
16 communities in providing alternatives to prison for low risk offenders ("407 funds"); and

17
18 WHEREAS, the State of Ohio Department of Rehabilitation and Correction, through the
19 CCA grant program, makes funds available to assist communities in providing programs that will
20 reduce the reliance on the local jails ("408 funds"); and

21
22 WHEREAS, the State of Ohio has awarded the County of Summit both 407 and 408
23 CCA grant funds for State Fiscal Year 2012, which were accepted and appropriated in
24 Resolution No. 2011-173 and Resolution No. 2011-174, and \$205,379.08 remains available, with
25 no local cash match requirement, through 6/30/12; and

27 WHEREAS, these CCA grant awards provide funding to the Court of Common Pleas,
28 Adult Probation Department, the Sheriff's Misdemeanor Residential and Jail Reduction
29 Programs and Oriana House, Inc.; and

31 WHEREAS, this Council finds and determines, by reviewing all pertinent information,
32 that it is necessary and in the best interest of the County of Summit to appropriate the
33 aforementioned funds in the amount of \$205,379.08;
