7 **A Resolution authorizing the County Executive to execute a three-year policing contract with**
8 **the City of Green, Council District 8, to provide seventeen full-time Sheriff's Deputies and one**
9 **Direct Indictment Officer at 20 hours per week, for the period 1/1/12 through 12/31/14, in the**
10 **amount of \$1,910,913.74 for the first year, \$1,931,733.06 for the second year and \$1,942,760.40**
11 **for the third year, in a total amount not to exceed \$5,785,407.20 during the three-year term of**
12 **the contract, for the Sheriff, and declaring an emergency.**

14 WHEREAS, this Council previously adopted Resolution No. 2009-350, which authorized the
15 County Executive to enter into a policing contract with the City of Green which terminates
16 December 31, 2011; and

17
18 WHEREAS, the City of Green hereby requests that the County Executive enter into a new
19 policing contract to provide seventeen full-time Sheriff's Deputies and one Direct Indictment Officer
20 at 20 hours per week, for the period 1/1/12 through 12/31/14; and

22 WHEREAS, the City of Green has agreed to pay the County \$1,910,913.74 for the first year,
23 \$1,931,733.06 for the second year and \$1,942,760.40 for the third year, for a total amount of
24 \$5,785,407.20 during the three-year term of the contract agreement; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information, that
27 authorizing the Executive to execute the aforementioned policing contract is necessary and in the
28 best interest of the County of Summit;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of
31 Ohio, that;

35 The County Executive is hereby authorized to execute a three-year policing contract with the
36 City of Green, Council District 8, to provide seventeen full-time Sheriff's Deputies and one Direct
37 Indictment Officer at 20 hours per week, for the period 1/1/12 through 12/31/14, in the amount of
38 \$1,910,913.74 for the first year, \$1,931,733.06 for the second year and \$1,942,760.40 for the third
39 year, for a total amount of \$5,785,407.20 during the three-year term of the contract.

43 This Resolution is hereby declared an emergency in the interest of the health, safety, and
44 welfare of the citizens of the County of Summit and for the further purpose of providing necessary
45 policing for the City of Green for 2012 through 2014.
