7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Prosecutor to hire**
9 **two external persons into the full-time, unclassified, non-bargaining position of Assistant**
10 **Prosecuting Attorney 2, up to the midpoint of the pay range, which is \$28.72 per hour, for**
11 **the Prosecutor, and declaring an emergency.**

13 WHEREAS, pursuant to Resolution No. 2009-110 and 2011-204, this Council enacted
14 and extended Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled
15 "Temporary Hiring Freeze," as a budgetary control measure; and

16
17 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that
18 the filling of an existing position by hiring an employee is necessary for the effective and
19 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
20 said employee; and

22 WHEREAS, due to the resignation of two full-time prosecuting attorneys in the
23 Prosecutor's Office, the Prosecutor proposes to hire two external persons into the full-time,
24 unclassified, non-bargaining position of Assistant Prosecuting Attorney 2, up to the midpoint of
25 the pay range, which is \$28.72 per hour; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to authorize the County
29 Prosecutor to hire two external persons into the full-time, unclassified, non-bargaining position
30 of Assistant Prosecuting Attorney 2, up to the midpoint of the pay range, which is \$28.72 per
31 hour;

33 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,

38 County Council hereby determines that it is necessary for the continued and effective
39 operation of the County Prosecutor's Office, and further authorizes the County Prosecutor to hire
40 two external persons into the full-time, unclassified, non-bargaining position of Assistant
41 Prosecuting Attorney 2, up to the midpoint of the pay range, which is \$28.72 per hour.

46 and welfare of the citizens of the County of Summit and for the further reason that it is necessary
47 to immediately authorize said hirings for the effective operation of the Prosecutor's Office.
