7 **A Resolution authorizing the County Executive to execute an Intergovernmental**
8 **Agreement with the City of Barberton to provide collective bargaining negotiation and**
9 **labor relations consulting services by Deputy Director Yamini Adkins to Barberton in its**
10 **collective bargaining negotiations with Fraternal Order of Police Lodge 13, for a fee of**
11 **\$60.00 per hour, for the Executive, and declaring an emergency.**

13 WHEREAS, Article II, Section 2.03(11) of the County of Summit Charter authorizes the
14 County Executive to conduct collective bargaining negotiations on behalf of County elected
15 officeholders; and

16
17 WHEREAS, the County maintains and operates a Department of Human Resources,
18 which through Deputy Director Yamini Adkins conducts said collective bargaining negotiations;
19 and

21 WHEREAS, Barberton wishes to have Ms. Adkins provide collective bargaining
22 negotiation and labor relations consulting services to Barberton in its collective bargaining
23 negotiations with Fraternal Order of Police Lodge 13; and

25 WHEREAS, in exchange for said collective bargaining negotiation and labor consulting
26 services, Barberton has agreed to pay the County a fee of \$60.00 per hour; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County of Summit to authorize the County
30 Executive to execute an Intergovernmental Agreement between the County and Barberton for the
31 aforementioned purposes;

33 NOW, THEREFORE, IT IS HEREBY RESOLVED by the Council of the County of
34 Summit, State of Ohio, that:

38 The County Executive is hereby authorized to execute an Intergovernmental Agreement
39 with the City of Barberton to provide collective bargaining negotiation and labor relations
40 consulting services by Deputy Director Yamini Adkins to Barberton in its collective bargaining
41 negotiations with Fraternal Order of Police Lodge 13, for a fee of \$60.00 per hour.

45 This Resolution is hereby declared to be an emergency measure in the interest of the
46 health, safety and welfare of the citizens of the County of Summit, Ohio, and for the further
47 reason that it is necessary in order to immediately authorize Ms. Adkins to provide labor
48 consulting services to the City of Barberton.

8 effect and be in force at the earliest time provided by law.


