7 **A Resolution adjusting existing appropriations by \$60,000.00 within the 2012 Court of**  
8 **Common Pleas – Juvenile Division’s general fund appropriations, for the fiscal year ending**  
9 **12/31/12, for the Court of Common Pleas - Juvenile Division, and declaring an emergency.**

11 WHEREAS, County Council previously adopted Resolution No. 2011-483, which  
12 approved and appropriated the 2012 operating budget, which included program funding in the  
13 Court of Common Pleas - Juvenile Division, for the fiscal year ending 12/31/12; and

15 WHEREAS, adjustments to the appropriations within the Court of Common Pleas –  
16 Juvenile Division’s General Fund operating budgets are needed in order to meet payroll needs;  
17 and

19 WHEREAS, a transfer of \$60,000.00 in the current operating budget appropriations, from  
20 the General Operations and Detention Center budgets to the Probation Department, is required in  
21 order to provide services; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that the adjustment of the appropriation of the aforementioned grant funds is necessary and in the  
25 best interest of the County of Summit;
