7 **A Resolution authorizing the Executive to execute an agreement with the City of Akron**
8 **whereby the Division of Animal Control will provide after-hours assistance for animals at-**
9 **large within the City of Akron, and the City of Akron will compensate the County for the**
10 **same, for the period of November 15, 2012 to March 31, 2013, for the Executive's**
11 **Department of Administrative Services, Division of Animal Control, and declaring an**
12 **emergency.**

14 WHEREAS, the Executive operates the Division of Animal Control under the
15 Department of Administrative Services; and

16
17 WHEREAS, the Division of Animal Control's functions include responding to calls,
18 transporting and impounding animals at-large within certain areas of the County through the use
19 of deputy dog wardens; and

20
21 WHEREAS, the City of Akron also employs dog wardens to provide response and
22 transporting of animals at-large that are within the City of Akron's territorial jurisdiction; and

23
24 WHEREAS, the City of Akron anticipates that for the period of November 15, 2012 to
25 March 31, 2013, it will need assistance from the County's deputy dog wardens for after-hours
26 calls within the City of Akron due to an illness of one of the City's of Akron's dog wardens; and

28 WHEREAS, the Executive desires to enter into an agreement with the City of Akron, for
29 the period of November 15, 2012 to March 31, 2013, whereby the Division of Animal Control
30 will provide the aforementioned after-hours assistance to the City of Akron, and the City of
31 Akron will compensate the County for the same; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
34 that it is necessary and in the best interest of the County to authorize the executive to execute the
35 aforementioned agreement with the City of Akron.

37 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
38 State of Ohio, that:

42 The Executive is hereby authorized to execute an agreement with the City of Akron
43 whereby the Division of Animal Control will provide after-hours assistance for animals at-large
44 within the City of Akron, and the City of Akron will compensate the County for the same, for the
45 period of November 15, 2012 to March 31, 2013, a copy of which is attached as Exhibit A.

49 This Resolution is hereby declared an emergency in the interest of the health, safety and
50 welfare of the citizens of the County of Summit and for the further reason to immediately
51 authorize the Executive to execute the said agreement so that the County may immediately begin
52 providing said services to the City of Akron.
