7 **A Resolution authorizing the County Executive to execute agreements and extensions to**  
8 **existing agreements with various local employers for participation and reimbursement**  
9 **through the Subsidized Employment Program, for the period 10/1/12 through 9/30/13,**  
10 **utilizing formulary Temporary Assistance to Needy Families funds, in a collective amount**  
11 **not to exceed \$500,000.00, for the Executive's Department of Job and Family Services, and**  
12 **declaring an emergency.**

13  
14 WHEREAS, pursuant to Resolution No. 2012-207, this Council authorized the County  
15 Executive to execute agreements and extensions to existing agreements with various employers  
16 for participation and reimbursement through the Temporary Assistance for Needy Families  
17 Subsidized Employment Program ("TANF SEP"), in an amount not to exceed \$215,000.00  
18 collectively, for the period 7/1/12 through 9/30/12; and

20 WHEREAS, following said approval, the County has entered into new SEP agreements  
21 and extensions to existing agreements with several employers whereby those employers will be  
22 reimbursed out of TANF SEP funds for expenses incurred due to newly hired employees; and

23  
24 WHEREAS, it is necessary to renew the approval for the expenditure of said TANF SEP  
25 funds for the period 10/1/12 through 9/30/13 and to allow the execution of new agreements and  
26 extensions of existing agreements during that time, in a collective amount not to exceed  
27 \$500,000.00; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
30 that it is necessary and in the best interest of the County to authorize the Executive to execute  
31 SEP agreements and extensions to existing agreements with various employers for participation  
32 and reimbursement through the SEP program, for the period 10/1/12 through 9/30/13, in a  
33 collective amount not to exceed \$500,000.00;

35 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
36 State of Ohio, that:

40 The County Executive is hereby authorized to execute Subsidized Employment Program  
41 ("SEP") agreements and extensions to existing agreements with various employers for  
42 participation and reimbursement through the SEP program for the period 10/1/12 through  
43 9/30/13, in a collective amount not to exceed \$500,000.00.

45 SECTION 2

47 This Resolution is hereby declared to be an emergency in the interest of the health, safety  
48 and welfare of the citizens of the County of Summit and for the further reason that it is necessary  
49 to immediately authorize the Executive to timely expend said funds prior to the close of the  
50 federal fiscal year on 9/30/13.
