27 contract with Language Line Services, Inc., for client translation services, for the period 3/1/12
28 through 5/31/13, in an amount not to exceed \$17,500.00 (70% increase), is hereby confirmed and
29 the County Executive is hereby authorized to execute such change order.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide additional client translation services
