8 **A Resolution appropriating funds in the amount of \$5,201,129.00 for the Moving Ohio**  
9 **Forward Demolition Program for the period 9/15/12 to 12/31/12, for the Executive's**  
10 **Department of Community and Economic Development, and declaring an emergency.**

11  
12 WHEREAS, the Summit County Land Reutilization Corporation ("Summit CLRC")  
13 applied for and received grant funds from the Ohio Attorney General's Moving Ohio Forward  
14 Demolition Program in the amount of \$3,780,560.00; and

15  
16 WHEREAS, the Moving Ohio Forward Demolition Program required that \$3,280,560.00  
17 of the grant be matched one-to-one with local funds, and the Summit CLRC has committed the  
18 sum of \$1,420,569.00 for the local match, with the balance of the match coming from the  
19 municipalities and townships within Summit County; and

20  
21 WHEREAS, the County and Summit CLRC will enter into a Subrecipient and  
22 Administration Agreement whereby the Summit CLRC will pass through to the County the  
23 \$3,780,560.00 in grant funds and \$1,420,569.00 in match from the Summit CLRC to the County  
24 and the County will administer the same and distribute the same to the municipalities and  
25 townships in Summit County; and

27 WHEREAS, said funds will be distributed to the municipalities and townships in Summit  
28 County by the County through Subrecipient Agreements with those municipalities and  
29 townships; and

30  
31 WHEREAS, it is necessary for this Council to appropriate the sums that will be received  
32 by the County from the Summit CLRC so that the same may be distributed to the municipalities  
33 and townships and administered by the County; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
36 that it is necessary and in the best interest of the County to appropriate the aforementioned funds  
37 to be received by the County from the Summit CLRC for the Moving Ohio Forward Demolition  
38 Program.

40 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
