7 **A Resolution confirming an award by the Board of Control for the renewals (first and**
8 **final) of professional service contracts for refugee resettlement social services, per attached**
9 **Exhibit A, for Federal Fiscal Year 2013, for the period 10/1/12 through 9/30/13, in a total**
10 **amount not to exceed \$275,119.00, for the Executive's Department of Job and Family**
11 **Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held September 12, 2012, awarded the
14 renewals (first and final) of professional service contracts for refugee resettlement social
15 services, per attached Exhibit A, for Federal Fiscal Year 2013, for the period 10/1/12 through
16 9/30/13, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract renewals are necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control for the renewals (first and final) of professional
27 service contracts for refugee resettlement social services, per attached Exhibit A, for Federal
28 Fiscal Year 2013, for the period 10/1/12 through 9/30/13, in a total amount not to exceed
29 \$275,119.00, is hereby confirmed and the County Executive is hereby authorized to execute such
30 contract renewals.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide for the contract renewals effective 10/1/12.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all


