7 **A Resolution confirming an award by the Board of Control of Change Order No. 1 to a**
8 **professional service contract with Quality Control Inspection, Inc., for additional**
9 **construction inspection services, in an amount not to exceed \$40,000.00 (80% increase), for**
10 **the Engineer, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held August 29, 2012, awarded Change
13 Order No. 1 to a professional service contract with Quality Control Inspection, Inc., for
14 additional construction inspection services, subject to confirmation by County Council; and

16 WHEREAS, this Council finds and determines, by reviewing all pertinent information,
17 that the change order is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of Change Order No. 1 to a professional service
25 contract with Quality Control Inspection, Inc., for additional construction inspection services, in
26 an amount not to exceed \$40,000.00 (80% increase), is hereby confirmed and the County
27 Executive is hereby authorized to execute such change order.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide additional construction inspection services.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
45 deliberations of this Council and of any of its committees that resulted in such formal action,


