A Resolution authorizing the County Executive to execute the second renewal (2nd of 2) of a contract with Medical Mutual of Ohio, subject to approval of the Board of Control, to provide flexible spending account management services for County employees, for the period 1/1/13 through 12/31/13, in an amount not to exceed \$4.30 per employee per month, for an estimated total not to exceed an amount of \$33,800.00 for 2013, for the Executive's Department of Law, Insurance and Risk Management, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution 2010-439 which authorized the County Executive to execute a contract with Medical Mutual of Ohio to provide flexible spending account management services for County employees, for the period 1/1/11 through 12/31/11, in an amount not to exceed \$4.30 per employee per month, for an estimated total not to exceed an amount of \$30,960.00 for 2011, with two options to renew for an additional one-year term; and

WHEREAS, Council previously adopted Resolution No. 2011-409, which authorized the Executive to execute the first renewal (1st of 2) of the aforementioned contract with Medical Mutual of Ohio, subject to the approval of the Board of Control, for the period 1/1/12 through 12/31/12, in an amount not to exceed \$4.30 per employee per month, for an estimated total not to exceed an amount of \$33,800.00 for 2012; and

WHEREAS, the County wishes to execute the second renewal (2nd of 2) of the aforementioned contract with Medical Mutual of Ohio, subject to approval of the Board of Control, for the period 1/1/13 through 12/31/13, in an amount not to exceed \$4.30 per employee per month, for an estimated total not to exceed amount of \$33,800.00 for 2013; and

WHEREAS, this Council finds determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute the aforementioned second renewal of the aforementioned contract with Medical Mutual of Ohio, subject to the approval of the Board of Control;
