A Resolution authorizing the County Executive to execute a six-month policing contract with the County of Summit Developmental Disabilities Board, to provide one Sheriff's Deputy and one shift vehicle, for the period 9/1/12 through 2/28/13, in a total amount not to exceed \$47,226.92, for the Sheriff, and declaring an emergency.

WHEREAS, the County of Summit Developmental Disabilities Board has requested that the County enter into a six-month policing contract to provide one Sheriff's Deputy and one shift vehicle, for the period 9/1/12 through 2/28/13; and

WHEREAS, the County of Summit Developmental Disabilities Board has agreed to pay the County the amount of \$7,871.15 per month, for total of \$47,226.92, for the period 9/1/12 through 2/28/13, and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned policing contract with the Developmental Disabilities Board is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

## **SECTION 1**

The County Executive is hereby authorized to enter into a six-month policing contract with the County of Summit Developmental Disabilities Board to provide one full-time Sheriff's Deputy and one shift vehicle, for the period 9/1/12 through 2/28/13, in a total amount not to exceed \$47,226.92 during the term of the agreement.

## SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the citizens of the County of Summit and for the further purpose of immediately providing necessary policing to the County of Summit Developmental Disabilities Board effective 9/1/12.

## **SECTION 3**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
