8 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
9 **Summit, entitled, "Temporary Hiring Freeze," to authorize the County Sheriff to hire one**
10 **external person into the full-time classified position of Civil Clerk I, at an annual salary of**
11 **\$23,296.00, the minimum salary for the position, for the Sheriff, and declaring an**
12 **emergency.**

14 WHEREAS, County Council previously adopted Ordinance No. 2009-110, which
15 enacted Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled,
16 "Temporary Hiring Freeze," to control and reduce the County's budget deficit and Ordinance
17 No. 2011-204, which reinstated the hiring freeze through December 31, 2012; and

18
19 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that
20 the filling of an existing position by hiring an employee is necessary for the effective and
21 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
22 said employees; and

24 WHEREAS, the County Sheriff says it is necessary for the continued and effective
25 operation of his Civil Division, to be permitted to hire one external person into the full-time
26 classified position of Civil Clerk I, at an annual salary of \$23,296.00, the minimum salary for the
27 position; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to authorize the County
31 Sheriff to hire one external person into the full-time classified position of Civil Clerk I, at the
32 aforementioned annual salary;

34 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
35 State of Ohio, that:

39 County Council hereby determines that the County Executive has demonstrated that it is
40 necessary for the effective and continued operation of the office to authorize the County Sheriff,
41 pursuant to Section 169.04(j) of the Codified Ordinances, to hire one external person into the
42 full-time classified position of Civil Clerk I, at an annual salary of \$23,296.00, the minimum
43 salary for the position.

47 This Resolution is hereby declared an emergency in the interest of the health, safety and
48 welfare of the citizens of the County of Summit and for the further reason to immediately
49 authorize the County Sheriff to hire one external person into the full-time classified position of
50 Civil Clerk I, for the continued and effective operation of the Civil Division for the Sheriff's
51 Office.
