WHEREAS, the Court of Common Pleas – Juvenile Division has received an award of a Federal Fiscal Year 2013 ("FFY 2013") Temporary Assistance to Needy Families ("TANF") grant from the Executive's Department of Job and Family Services, for the Juvenile Court's Family Resource Center ("FRC") program, in the amount of \$340,000.00, with no local cash match requirement, for the period 10/1/12 through 9/30/13; and

WHEREAS, the FRC program provides families with intensive case management to atrisk youth who are involved in any of the following situations: domestic violence, pregnancy, parenting teens, teens at risk of dropping out of school and/or returning from long stays at the detention center or other placement center; and

WHEREAS, the FRC program also provides resources for other court-involved youth, and the County as a whole, being the central point of referral for all services available throughout the County for youth and their families; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to accept the award of the aforementioned FFY 2013 TANF grant from the Executive's Department of Job and Family Services to the Juvenile Court, and to appropriate these grant funds;
