7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with the County of Summit Sheriff's Office for reimbursement of IV-D provider**
9 **contract services for service expenses related to Child Support Enforcement Agency**
10 **criminal non-support extraditions, for the period 10/1/12 through 9/30/13, in an amount**
11 **not to exceed \$110,600.00, for the Prosecutor – Child Support Enforcement Agency, and**
12 **declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held August 8, 2012, awarded a
15 professional service contract with the County of Summit Sheriff's Office for reimbursement of
16 IV-D provider contract services for service expenses related to Child Support Enforcement
17 Agency criminal non-support extraditions, for the period 10/1/12 through 9/30/13, subject to
18 confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the contract is necessary and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
24 of Ohio, that:

28 The award by the Board of Control of a professional service contract with the County of
29 Summit Sheriff's Office for reimbursement of IV-D provider contract services for service
30 expenses related to Child Support Enforcement Agency criminal non-support extraditions, for
31 the period 10/1/12 through 9/30/13, in an amount not to exceed \$110,600.00, is hereby
32 confirmed and the County Executive is hereby authorized to execute such contract.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the citizens of the County of Summit, and for the further reason to immediately
38 provide for the reimbursements effective 10/1/12.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.

49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
50 deliberations of this Council and of any of its committees that resulted in such formal action,
