7 **A Resolution confirming an award by the Board of Control of a renewal of a purchase**
8 **contract (second and final) with Brinks for armored car services for various county**
9 **departments, for a one-year period, in an amount not to exceed \$2,724.02 per month, for a**
10 **total amount not to exceed \$32,688.24, for the Executive's Department of Finance and**
11 **Budget - Purchasing, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held July 25, 2012, awarded a renewal
14 of a purchase contract (second and final) with Brinks for armored car services for various county
15 departments, for a one year period, subject to confirmation by County Council; and,

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the contract renewal is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

25 The award by the Board of Control of a renewal of a purchase contract (second and final)
26 with Brinks for armored car services for various county departments, for a one-year period, in an
27 amount not to exceed \$2,724.02 per month, for a total amount not to exceed \$32,688.24, is
28 hereby confirmed and the County Executive is hereby authorized to execute such contract
29 renewal.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide the aforementioned armored car services.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,

49 121.22 of the Ohio Revised Code.

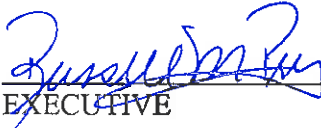
