7 **A Resolution appropriating additional funds within the Psycho-Diagnostic Clinic Fund, in**
8 **the amount of \$9,776.00, and within the Adult Probation Services Revenue Fund, in the**
9 **amount of \$160,000.00, and within the General Division Special Projects Fund, in the**
10 **amount of \$250,000.00, for a grand total of \$419,776.00, through 12/31/12, for Court of**
11 **Common Pleas General Division, and declaring an emergency.**

13 WHEREAS, the Court of Common Pleas General Division has cash reserves of
14 \$9,776.00 from fees collected for services provided to other counties, by the Psycho-Diagnostic
15 Clinic; and

17 WHEREAS, the Court of Common Pleas General Division has cash reserves of
18 \$160,000.00 from fees collected from probation clients for services provided by the Court's
19 Adult Probation Department; and

21 WHEREAS, the Court of Common Pleas General Division has cash reserves of
22 \$250,000.00 in the Special Projects Fund from the various fees and awards collected by the
23 Court; and

25 WHEREAS, the cash reserves are needed for staffing costs within these Court of
26 Common Pleas Departments; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County of Summit to appropriate the
30 aforementioned funds in the amount totaling \$419,776.00;
