7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with the County of Summit Fiscal Office for reimbursement of payment collection**  
9 **services for IV-D provider contracts, for the period 7/1/12 through 6/30/13, in an amount**  
10 **not to exceed \$87,157.22, for the Prosecutor – Child Support Enforcement Agency, and**  
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held July 25, 2012, awarded a  
14 professional service contract with the County of Summit Fiscal Office for reimbursement of  
15 payment collection services for IV-D provider contracts, for the period 7/1/12 through 6/30/13,  
16 subject to confirmation by County Council; and,

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

26 The award by the Board of Control of a professional service contract with the County of  
27 Summit Fiscal Office for reimbursement of payment collection services for IV-D provider  
28 contracts, for the period 7/1/12 through 6/30/13, in an amount not to exceed \$87,157.22, is  
29 hereby confirmed and the County Executive is hereby authorized to execute such contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the citizens of the County of Summit, and for the further reason to immediately  
35 provide for the contract effective 7/1/12.

37 SECTION 3

39 Provided this Resolution receives the affirmative vote of eight members, it shall take  
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating  
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
47 deliberations of this Council and of any of its committees that resulted in such formal action,  
48 were in meetings open to the public, in compliance with all legal requirements, including Section  
49 121.22 of the Ohio Revised Code.


