12 WHEREAS, Resolution No. 2009-303 originally accepted a 2009 Juvenile Assistance  
13 Grant through the American Recovery and Reinvestment Act of 2009 ("JAG ARRA") as a pass  
14 through award of \$38,128.45 from the City of Akron for the County Sheriff, with funding  
15 available through the fiscal year ending 12/31/13; and

17 WHEREAS, \$2,000.00 in current remaining funds were appropriated by Resolution No.  
18 2012-070 and require an adjustment in order to best meet the needs of the Sheriff's office; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that the adjustment of the appropriation of the aforementioned grant fund is necessary and in the  
22 best interest of the County of Summit;
