7 **A Resolution authorizing the County Executive to advertise for bids for the replacement of**
8 **the roof at the County of Summit Department of Environmental Services storage building**
9 **located at 150 East South Street, in Council District 4, for an estimated total cost not to**
10 **exceed \$40,000.00, for the Executive's Department of Administrative Services – Physical**
11 **Plants, and declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
14 requires this Council's authorization for the County Executive to advertise for bids; and

16 WHEREAS, the County Executive wishes to advertise for bids for the replacement of the
17 roof at the County of Summit Department of Environmental Services storage building located at
18 150 East South Street, in Council District 4, for an estimated total cost not to exceed \$40,000.00;

21 WHEREAS, a copy of the specifications are attached as Exhibit A; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that is necessary and in the best interest of the County of Summit to authorize the Executive to
25 advertise for bids for the aforementioned project;

32 The County Executive is authorized to advertise for bids for the replacement of the roof
33 at the County of Summit Department of Environmental Services storage building located at 150
34 East South Street, in Council District 4, for an estimated total cost not to exceed \$40,000.00.

38 This Resolution is declared an emergency in the interest of the health, safety, and welfare
39 of the citizens of the County of Summit, and for the further reason that it authorizes the
40 Executive to immediately advertise for bids for the County of Summit Department of
41 Environmental Services storage building roof replacement project to correct the leaking and to
42 avoid damage to stored equipment and supplies.
