7 **A Resolution authorizing the County Executive to execute a Human Resource Training**
8 **Agreement with political subdivisions that wish to participate in the County's Human**
9 **Resource Training Program, for the Executive's Department of Human Resources, and**
10 **declaring an emergency.**

12 WHEREAS, all political subdivisions must engage in certain training of their employees;
13 and

14
15 WHEREAS, the County desires to collaborate with those political subdivisions by
16 offering the County's employee training to the employees of those political subdivisions; and

17
18 WHEREAS, to facilitate such training, the Executive's Office has developed a Human
19 Resource Training Agreement; and

20
21 WHEREAS, the County has further determined that a political subdivision's participation
22 under the Human Resource Training Agreement shall be operated on a cost-neutral basis to the
23 County and that accordingly, the participating political subdivision shall pay certain fees as set
24 forth in the Human Resource Training Agreement; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
28 execute the aforementioned Agreement with political subdivisions that wish to participate in the
29 Human Resource Training Agreement;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:

34 SECTION 1

35
36 The County Executive is hereby authorized to execute a Human Resource Training
37 Agreement, attached hereto as Exhibit A and incorporated herein as if fully restated, with
38 political subdivisions that wish to participate in the County's Human Resource Training
39 Program. The Human Resource Training Agreement is approved with changes therein not
40 inconsistent with this Resolution and not substantially adverse to the County which shall be
41 approved by the County Executive; provided that the approval of those changes by the County
42 Executive and the character of such changes as not being substantially adverse to the County
43 shall be evidenced conclusively by the execution of the Human Resource Training Agreement.

45 SECTION 2

47 This Resolution is hereby declared an emergency in the interest of the health, safety and
48 welfare of the citizens of the County of Summit and for the further purpose of immediately
49 authorizing the Executive to execute a Human Resource Training Agreement with County
50 political subdivisions that wish to participate in the County's Human Resource Training
51 Agreement, in order to fulfill the training needs of those political subdivisions.

9 effect and be in force at the earliest time provided by law.


